FasalPay Commodity Pricing Application Terms & Conditions

1. Introduction & Acceptance

By using the FasalPay Commodity Pricing Application (the "App" or "FasalPay") you agree to comply with these Terms and Conditions ("Terms"), which form a legally binding agreement between you and **FasalPay**. If you do not agree to these Terms, you must immediately discontinue use of the App. We may update these Terms from time to time. 2. Definitions

For the purpose of these Terms:
